**VERIFIED COMPLAINT FOR
PRELIMINARY AND PERMANENT INJUNCTIVE RELIEF**

1. This complaint concerns enforcement of the Ohio Revised Code (hereinafter "R.C.") Chapter 3767 et seq., other code provisions, and common law so as to be within the exclusive jurisdiction of the Environmental Division of the Franklin County Municipal Court pursuant to R.C. § 1901.183.
2. Relator-Plaintiff Richard C. Pfeiffer, Jr. is the duly-elected, sworn, and acting City Attorney for the City of Columbus, Ohio and is a party charged at both common law and by R.C. § 3767.03, R.C. §713.13 and R.C. § 715.30 with the prevention, prosecution, and abatement of any public nuisance within the City of Columbus, Franklin County, Ohio.
3. The Court has personal jurisdiction over the individual Defendant pursuant to R.C. §2307.382(A)(8) since the basis of this complaint is real property situated in Franklin County, Ohio.

4. The real property that is the subject matter of this complaint is located at 2595 Hiawatha Street, Columbus, Ohio, 43211, (hereinafter “the Premises”), known as Franklin County Permanent Parcel No. 010-018312, situated in the City of Columbus, Franklin County, Ohio. (See *Attached Plaintiff’s Exhibits A and B*).
5. All Respondents-Defendants have been owners, occupants, and/or persons with charge, care or control of the Premises at all times relevant to this Complaint.
6. Respondent-Defendant Edward Antauer (hereinafter “property owner”) is the owner of 2595 Hiawatha Street, Columbus, Ohio 43211 by virtue of a General Warranty Deed from Michael Mann and Judith Mann, Franklin County Instrument Number 200306130177533. (See *Attached Plaintiff’s Exhibit B*).
7. Respondent-Defendant Tom Casto, individually, has exerted charge, care and control over the property, maintained a nuisance, and is a proper party defendant.
8. Respondent-Defendant Chris Miller, individually, has exerted charge, care and control over the property, maintained a nuisance, and is a proper party defendant.
9. Respondent-Defendant Wayne Miller, individually, has exerted charge, care and control over the property, maintained a nuisance, and is a proper party defendant.
10. Respondent-Defendant Catherine Adkins, individually, has exerted charge, care and control over the property, maintained a nuisance, and is a proper party defendant.
11. Respondent-Defendant State of Ohio, Department of Taxation may have an interest in the property by virtue of a Certificate of Judgment against Edward Antauer, Vol. No. 07JG-02-03083, filed February 20, 2017.
12. Respondent-Defendant Unknown Tenant and/or Occupant, individually, has exerted charge, care and control over the property, maintained a nuisance, and is a proper party defendant.

13. The Premises is a single-family dwelling located east of Interstate Highway 71, west of Cleveland Avenue, south of Weber Road, and approximately two blocks north of Hudson Street.
14. The Premises is within a half-mile radius of the following locations:
 - a. Columbus Alternative High School
 - b. Linden Community Recreational Center
 - c. Audubon Park
15. In the summer of 2016, the Columbus Police Department initiated an investigation in response to a community complaint about the Premises operating as a drug house.
16. On September 19, 2016, the Columbus Police Department's Narcotics Unit conducted a covert investigation. The Columbus Police Detectives, utilizing a confidential informant, gained entry into the Premises. The confidential informant purchased crack cocaine from an occupant. The contraband was turned into the Columbus Police Property Room under #16-20888. (*See Attached Plaintiff's Exhibits C and D*).
17. On September 26, 2016, the Columbus Police Department's Narcotics Unit conducted a covert investigation. The Columbus Police Detectives, utilizing a confidential informant, gained entry into the Premises. The confidential informant purchased crack cocaine from an occupant. The contraband was turned into the Columbus Police Property Room under #16-21440. (*See Attached Plaintiff's Exhibits E and F*).
18. On September 27, 2016, the Columbus Police sent a letter via certified mail to the owner, Edward Antauer, notifying him that drugs were being sold at the premises. The letter informed Mr. Antauer that he is obligated to take action, and his failure to do so, may result in a nuisance abatement action. The letter was delivered and signed for on September 30, 2016. (*See Attached Plaintiff's Exhibit G*).

19. On October 6, 2016, Code Enforcement received a complaint alleging interior and exterior violations at the property, including no water service and lack of walls inside the occupied structure. Code Enforcement Officer Jasmine Mattox (hereinafter “Mattox”) verified the utilities were off.
20. On or about October 27, 2016, Mattox inspected the exterior of the premises and observed that the yard area was being used for storage. Mattox spoke to a person alleging to be a tenant, Tom Casto, who stated he was trying to build a shed. Code violation notices for exterior violations were issued to the owner and Mr. Casto, as well as an emergency notice to the owner to restore water service. (*See Attached Plaintiff's Exhibit H*).
21. On or about December 5, 2016, Columbus City Division of Water informed property owner, Mr. Antauer, that he would have to permit access into the dwelling in order for them to turn the water on. Mr. Antauer scheduled an inspection but then cancelled it stating that the property was vacant.
22. On or about December 6, 2016, Mattox received a complaint that the property was still occupied without appropriate sanitary facilities in the dwelling, as well as missing walls, kitchen, and steps leading to the attic and basement area.
23. In January of 2017, Mattox inspected the exterior and found it to not be in compliance. Mattox sent a warning letter to the owner. Additionally, Mattox issued vacant housing notices to the owner, as he insisted the property was vacant. (*See Attached Plaintiff's Exhibit I*).
24. On February 24, 2017, Mattox conducted an inspection and spoke to Mr. Casto, who claimed he no longer lived at the house, but now resided five houses down the street. Code Enforcement continued to receive reports of people going into the dwelling on a regular basis.

25. On May 10, 2017, the Columbus Police received a new community complaint of drug deals going on at the property at all hours of the day and night.
26. On May 16, 2017, Mattox and Code Enforcement Supervisor Maria Babb (hereinafter "Babb") observed four men coming out of the premises, one of them being Mr. Casto. Mr. Casto and two other men walked away. One of the men returned inside the dwelling. A female arrived and went inside the house. Mattox and Babb attempted to gain permission to enter to inspect the interior. Occupants refused to identify themselves or to provide entry. Code inspectors asked the male occupant if he was living as the property, and he responded, "No, I'm just working inside the dwelling."
27. On May 23, 2017, Code Enforcement (Mattox, Babb, and Inspector Kurt Schmitter), with assistance from Columbus Police SWAT Unit, executed an administrative search warrant at the premises. There were three people inside the dwelling. The individuals inside were Chris Miller, Wayne Miller and Catherine Adkins. Chris Miller stated that he works for the property owner in exchange for being allowed to live the dwelling. Wayne Miller and Ms. Adkins stated they both paid rent to Mr. Antauer in exchange for use of the premises.
28. During the execution of the administrative search warrant, Code Enforcement found evidence of occupancy (multiple beds, bucket of feces), drugs, and multiple Code violations, including no working sanitary facilities, no walls, exposed wires and other violations. The property was immediately vacated. (*See Attached Plaintiff's Exhibit J*).
29. After the inspection, Mattox contacted Mr. Antauer and asked to meet him at the property. When he arrived, he was asked if he was aware of the conditions inside the structure and he stated "yes". Mr. Antauer stated that he did not know anybody was staying there, but he knew Tom Casto as a heroin user. Mr. Antauer stated that years ago, Tom Casto was shot in the head for a bad drug transaction at 2595 Hiawatha Street. Mr. Antauer said that the

other occupants inside the house were his “workers”. After the conversation, Mr. Antauer arranged to transport the occupants to work on another one of his properties.

30. Relator-Plaintiff alleges that the property located at 3029 Gerbert Road, Columbus, Ohio, 43224 is a public nuisance as defined in R.C. § 3767.01, § 3767.12, C.C.C. § 4703, C.C.C. § 703.17, C.C.C. § 4501.275 and under common law, subject to abatement under R.C. § 3767.
31. Relator-Plaintiff asserts that the Premises herein has generally reputed to be kept, conducted, and maintained for the purposes of committing violations of Ohio Revised Code 2925, and is therefore a public nuisance subject to abatement.
32. Relator-Plaintiff asserts that the Premises herein in its non-compliant state, does not comply with the provisions of the Columbus Health, Sanitation and Safety Code-Title 7, Columbus Zone Code-Title 33, and Columbus Nuisance Abatement Code- Title 45 and/or Title 47 or with the provisions of the Columbus and Ohio Building Codes.
33. Respondents-Defendants are guilty of maintaining a nuisance at the premises, subject to abatement in accordance with R.C. 3767.01 (*et seq.*), for having a structure in violation of the laws pertaining to illegal drugs (including violations of R.C. Chapter 2925, R.C., R.C. 3719.10, etc.); such operations at the premises substantially interfere with the area’s public decency, sobriety, peace, safety, welfare, and good order.
34. Respondents-Defendants own fixtures, furniture, and moveable property that have been used or are currently being used in conducting, maintaining, and facilitating said public nuisance.
35. Respondents-Defendants at all times relevant to this action maintained a public nuisance threatening the health, safety, and welfare of the People of the City of Columbus.

36. Respondents-Defendants are guilty of maintaining a nuisance at the premises based on their actual and constructive knowledge of the nuisance, as well as the well-known general reputation of the premises, which is *prima-facie* evidence of the nuisance and of knowledge of and of acquiescence and/or participation in the nuisance.

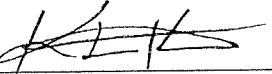
WHEREFORE, Relator-Plaintiff demands judgment as follows:

1. Per R.C. § 3767 and Ohio Civ.R. 65(B)(2), that the court set a preliminary injunction hearing on the matter at the earliest possible time, so that the remedies of R.C. Chapter 3767 and/or any equitable remedies may be enforced and the preliminary injunction granted where the entire premises (or portions) shall then be boarded up alongside an order directing the removal of all personal property and contents used in conducting or maintaining the nuisance.
2. That the premises located at 2595 Hiawatha Street, Columbus, Ohio, 43211 be declared a public nuisance as defined in Ohio Revised Code § 3767.01(C)(3) and Columbus City Code § 4703, R.C. § 3767.01, R.C. § 3767.12, C.C.C. § 4703, C.C.C. § 703.17, C.C.C. § 4501.275 and under common law, subject to abatement under R.C. § 3767 and the City Codes.
3. That all Respondent-Defendants be found to have been maintaining a public nuisance as defined in R.C. § 3767.01, Columbus City Code § 4703 and under common law as alleged herein.
4. In accordance with this Complaint and Revised Code Chapter 3767, that Respondents-Defendants, and each of them, as the owners and/or persons in control of the Premises, and any heirs, successors in interest or title, and assigns be permanently enjoined from conducting, maintaining, using, occupying, or in any way permitting the use of the Premises as a public nuisance.

5. In accordance with this Complaint and Revised Code Chapter 3767, that Respondents-Defendants, and each of them, be permanently enjoined from conducting, maintaining, using, occupying, or in any way permitting the use of a public nuisance anywhere in Franklin County, Ohio, and/or Columbus, Ohio.
6. On final judgment, the Chief of Police of Columbus, Ohio be ordered to sell the furniture, fixtures, and moveable property identified herein in the manner provided for the sale of chattels under execution, and effectually close the premises against its use for a one year period.
7. To prohibit the Respondents-Defendants from occupying or permitting occupancy of the Premises after the one year closure period until an inspection by Code Enforcement is conducted and the property is deemed habitable and in substantial compliance with Columbus City Code.
8. An order authorizing the City to abate the nuisance activity at the Premises during the closure period, at the Respondent-Defendants' expense.
9. To tax each Respondent-Defendant \$300 in accordance with Revised Code § 3767.08, plus the costs of this action.
10. That this Court appoint a receiver pursuant to Chapter 2735 of the Ohio Revised Code.
11. An award of Plaintiff-Relator's cost, including costs of abatement board-up, court costs, and attorneys' fees payable by Respondents-Defendants.
12. Any other relief, at law or equity, as this Court may deem proper.

The C/I stated that he/she paid \$20.00 for the illegal contraband. The C/I was again searched and no drugs or money were found on his/her person.

The C/I stated that he/she walked into the front yard of 2595 Hiawatha Street when a F/W/30s, 5'6" and 110 lbs., exited the house and walked over to the C/I. The F/W asked the C/I what he/she wanted. The C/I stated a "twenty". The F/W reached into her pocket and handed the C/I a small baggie containing crack/cocaine in exchange for \$20.00 of pre-recorded city funds. The C/I left the address and immediately returned to the waiting detectives.

The C/I was dropped off and the detectives turned the suspected contraband into the Columbus Police Property Facility under property #16/20888 to be analyzed. The contraband weighed 10.3 gram(s) (packaged weight).

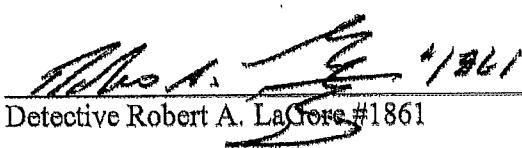

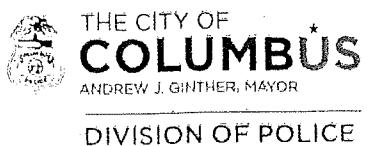

To Whom It May Concern,

On 9/19/16 a controlled purchases of illegal narcotics was conducted at 2595 Hiawatha St as a result of an investigation of conduct that violates Ohio Revised Code Chapter 2925 – Drug Offenses. The Franklin County Auditor's Office indicates that you are the owner of said property. The purpose of this letter is to notify you of the Chapter 2925 violations occurring at said property.

Pursuant to Ohio Revised Code Section 1923.02(A)(6)(a)(i), you now have "actual knowledge of or reasonable cause to believe" a violation of Revised Code Chapter 2925 exists at 2595 Hiawatha St.

Under the Ohio Revised Code "...the landlord shall terminate the...rental agreement...if a tenant previously has or presently is engaged in a violation of...Chapter 2925...of the Revised Code..." It is incumbent upon you to commence eviction proceedings against your tenant, or anyone occupying this property. If you are unsure how to evict legal tenants, or ones with which you have no legal agreement, please contact an attorney.
