CITY ATTORNEY ANNOUNCES LATEST FUGITIVE OF THE WEEK

*Franklinton man with six prior OVI convictions is wanted
on five additional DUI-related charges*

COLUMBUS, OH—Columbus City Attorney Richard C. Pfeiffer, Jr. announced that Brian Legg, Sr. is the latest target of his “Fugitive of the Week” program. Legg, 44, is wanted on arrest warrants for failing to appear in court to answer five OVI-related charges and for violating his probation from an earlier OVI conviction.

“We want to alert the general public to be on the lookout for this man with six previous OVI convictions,” said City Attorney Richard C. Pfeiffer, Jr. **“We’re concerned that he will jeopardize the safety of others if he continues his pattern of drinking and driving.”**

Legg was last arrested when police officers witnessed his truck on the curb and sidewalk at the intersection of Sullivant Ave. and Eureka Ave. on the city’s west side. Legg initially tried to walk away from the officers when they approached and questioned him. He subsequently failed field sobriety tests and had a blood alcohol content well over the legal limit. Legg previously had been convicted of OVI on:

- 4/25/1988
- 11/21/1988
- 5/30/1989
- 9/12/1990
- 2/21/2002
- 2/28/2007

“Mr. Legg, like many others, could have come forward during the Fugitive Safe Surrender program,” said Assistant City Prosecutor Bill R. Hedrick, who leads the fugitive apprehension program on Pfeiffer’s behalf. **“Instead, he chose to continue his game of cat-and-mouse, so hopefully we’ll hound him down with the public’s help.”**
